ZILLION STANDARD LIMITED WARRANTY

All ZILLION fuel injection products are covered by our 12-Month, Unlimited Mileage, Limited Warranty. Certain other products supplied by ZILLION may have specific warranties, detailed in the product documentation.

This warranty comes into effect on April 1, 2024, and applies exclusively to ZILLION branded fuel injection parts and components provided by ZILLION installed after this date. Installation must be carried out by certified Diesel Technicians at Service Centers specializing in Internal Engine Repair.

ZILLION will conduct analyses on returned parts and determine the cause of failure and the consideration of damages, if any. ZILLION's determinations are final and binding within the limits of this warranty.

ZILLION assumes no responsibility for any incidental or consequential damages beyond those outlined below:

Labor Policy:

Zillion will cover labor, diagnosis, and consequential damages resulting from material or workmanship defects, up to a maximum of \$4000 in labor and \$1000 in total expenses and other damages per incident.

Warranty Coverage: The ZILLION Fuel Injection Warranty **COVERS** and **INCLUDES**:

- Defective parts in material and workmanship for 12 months from the date of installation or 18 months from warranty injector date code, whichever comes first.
- Labor costs for the removal and re-installation of affected parts, not exceeding \$5000 per incident.
- Labor rates and standards will be determined according to national standards and is currently set at \$100.00 per hour.



Let's Get to Work

Warranty Exclusions: The Zillion Fuel Injection Warranty DOES NOT COVER and thus EXCLUDES:

- Failures due to fuel or oil contamination, misuse, negligence, fire damage, modification, abuse, improper application, installation, or operation.
- Claims submitted later than 15 days after the failure date.
- Failures caused by the re-use of electrical wire harnesses or connectors.
- Failures caused by modifications or power-enhancing devices, high-performance, racing, or off-road applications.
- Use of Biodiesel Fuel.

This warranty does not extend to any product that is worn or damaged due to improper installation, neglect, oil, fuel, or coolant contamination, foreign object debris, fire, modification, improper maintenance, misuse, accident, or normal wear. Proof of purchase is required from the original using customer, effective from the date of sale.

Owner Responsibilities:

- Covering the cost of all necessary fluids, filters, wiring harnesses, and other parts required for repair.
- Ensuring due diligence in all maintenance and proper operation of the engine as specified in the relevant operation and maintenance manuals.
- Bearing all travel, towing, meals, lodging, and similar costs incurred because of a warrantable failure.
- Covering downtime expenses and all business costs and losses arising from a warrantable failure.
